## Why Were The Items Distributed Here? What Are The Greatest Needs In This Community?

Makeni Simpson is a low-income community where many elderly people, widows, and families living with chronic illness struggle to meet their daily needs. Access to stable income is limited, and many households depend entirely on informal help from neighbours, churches, and extended family. Distributing clothing and food in this community ensures that vulnerable households especially those caring for elderly or disabled family members receive essential support that they cannot afford on their own. In Makeni Simpson and similar informal settlements in Lusaka, many residents lack stable access to basic services and live in severe poverty. These high-density areas are overcrowded, with poor housing quality, and inadequate water and sanitation infrastructure. (The United Nations in Zambia) While shallow wells often supply water, it is frequently untreated and contaminated, creating serious health risks. (PMC) Many households rely on informal employment or inconsistent support, making it difficult to afford essentials like food, clothing, and medical care. The lack of clean water, reliable sanitation and adequate income poses grave challenges, particularly for the most vulnerable, the elderly, those with disabilities, and full-time caregivers.

What Are Their Living Conditions?
Norah lives with her 83-year-old husband and her 100-year-old in Makeni Simpson, one of Lusaka's
low-income settlements where many families face overcrowded housing, limited income
opportunities, and unreliable access to basic services. Her living conditions are challenging: he

husband suffered a stroke in 2019 and is fully dependent on her for mobility and daily care, while

her mother is nearly blind, hard of hearing, and requires constant supervision. Because Norah is the sole caregiver for both of them, she is unable to work or run a small business, leaving the household with no stable source of income. The family survives on intermittent support from well-wishers and her children, although this help is inconsistent and usually less than K500 per month. They rely on a shallow well at their home for water, which they drink untreated, exposing them to health risks. With limited resources, Norah struggles to provide daily meals, basic necessities, and safe living conditions for her elderly family or two meals a day.

#### **Describe The Types Of Needs This Individual Has.**

Her family's needs are wide-ranging. She requires consistent access to balanced meals for herself, her husband, and her elderly mother, as well as safe drinking water and basic hygiene supplies to reduce health risks. Overall, Norah requires ongoing support to lessen the physical and emotional strain of caring for two frail family members while having no stable source of income as she herself is also old.

## **How Did This Donation Meet These Needs And Make A Lasting Impact?**

The donation of hoodies, sweaters, and t-shirts provided immediate warmth and a sense of relief to a family unable to afford clothing. The donation also reaffirmed to Norah that she is not carrying the weight of her caregiving responsibilities alone; someone sees her and cares about her well-being.

Why Were The Items Distributed Here? What Are The Greatest Needs In This Community?

The donation was directed to Chongwe District Health Center because it serves an estimated population of over 350,000 people through 43 health facilities, including 35 delivery sites and one district hospital, making the District Health Office a central hub for distributing essential supplies. With births having risen from fewer than 100 to over 400 per day, the demand for PPE and basic items has significantly increased across the district. At the time of the donation, Chongwe was also responding to emerging cholera cases, creating an urgent need for protective equipment to safeguard both health workers and patients. Providing these items ensured that the District Health Center could strengthen its response capacity, support the most under served facilities, and continue delivering safe and effective care to the rapidly growing population.

Because the district is the distribution hub for all 43 facilities, the items donated will be spread out to the most under served areas, creating a district-wide impact rather than benefiting just one facility. #### What Are Their Living Conditions?

Bedes is a widow who has lived in Kanyama for over ten years. She currently stays in a small one-room house that her family provided after her husband passed away. The space is overcrowded and partitioned to create a sleeping area for the children and a small cooking corner. Despite her efforts to make it functional, the structure is fragile and leaks during the rainy season, often leaving the family cold and uncomfortable. With eight school-going children under her care and no stable source of income, the household faces daily challenges in maintaining basic living standards.

#### **Describe The Types Of Needs This Individual Has.**

Bedes's needs are extensive due to the size of her household and the limited income she generates. She requires consistent access to food, especially for the children who often eat only once a day. She also needs proper clothing and shoes for the children to attend school and church

with dignity. The family lacks reliable shelter, particularly a roof that can protect them during the rainy season. Additionally, Bedes needs ongoing support to manage essential expenses such as food, school-related costs, and household necessities.

## **How Did This Donation Meet These Needs And Make A Lasting Impact?**

The donation of hoodies, T-shirts, shoes, mosquito nets, food items, and other essentials provided immediate relief to Bedes's family. The warm clothing ensures the children are protected during the cold season, and the new clothes and shoes allow them to attend school and church confidently, something they previously relied on neighbors to provide. The food supplies reduced the pressure on Bedes, giving the children consistent meals and easing one of her greatest daily struggles. This support has strengthened the family's well-being during a difficult period.

Why Were The Items Distributed Here? What Are The Greatest Needs In This Community?

The cot beds were distributed to Chongwe District Health Centre because it serves as one of the busiest facilities in a district of over 350,000 people, acting both as a primary care provider and a central point where surrounding facilities come to access essential supplies. With births in the district now exceeding 400 per day and many children needing urgent care, the center and surrounding centers face shortages in bed space, especially when multiple patients arrive at once or when children are brought in unable to walk. Staff expressed that the new stretchers will not only support the safe transfer of patients who cannot move on their own but will also double as additional bed space during high-pressure moments when the facility is overwhelmed. Given the community's growing population, the limited infrastructure, and the high demand for pediatric and maternal services, these cot beds directly address one of the greatest and most persistent needs in the area.

The donation of stretchers/cot beds made a lasting impact by directly addressing the shortage of patient beds at Chongwe District Health Center. Staff reported that patients who could not walk due to shortage of wheelchairs and stretchers will now get immediate help when they arrive at the facility. Additionally, the stretchers provide flexible space for children during peak periods, ensuring that all patients receive timely attention. Beyond the immediate benefits, these resources strengthen

the center's capacity to serve not only its own patients but also other facilities that depend on it for support, creating a ripple effect of improved healthcare access in the community.

With limited space, unstable income, and inconsistent help from her surviving children, who also struggle financially, the household faces ongoing challenges in meeting daily needs. Paying rent and securing enough food are constant worries.

## **Describe The Types Of Needs This Individual Has.**

Mirriam's needs revolve around securing the basic necessities required to sustain her household. She urgently needs reliable access to daily meals for her grandchildren, along with a stable income that can consistently cover rental payments. Warm and adequate clothing is essential, especially for

the children who are growing and face cold, rainy seasons without proper attire.
